Purpose: To gather feedback and insights to improve our app designed for nonverbal communication.

1. Voluntary Participation

By signing up, you agree to participate voluntarily in testing our app. You may stop participating at any time without penalty or explanation.

2. Confidentiality

🔒 Please **do not share** any personal or sensitive information (such as medical details, addresses, or private communication) while using or testing the app.

🔒 Do not post or share screenshots, recordings, or descriptions of the app design, features, or testing materials publicly.

🔒 You agree not to distribute or disclose any non-public information about the app.

3. Data and Feedback Use

Your feedback will be used **only for research and product improvement** by DesiHeart Inc.

We may collect general information such as your age group, experience with communication tools, and testing feedback.

We do **not** sell, trade, or rent your personal information to anyone.

4. No Payment or Employment Relationship

This is an unpaid, volunteer opportunity. Participation does not create an employment, contractor, or agency relationship with DesiHeart Inc.

5. App Testing Risks

This is a test version of the app and may contain bugs or incomplete features. You agree to use it for testing only and understand that DesiHeart Inc. is not responsible for any technical issues, data loss, or errors during testing.

6. Waiver of Liability

By participating in this testing program, you understand and agree that:

- You are engaging in app testing **at your own risk**.
 - DesiHeart Inc and its team are **not liable** for any direct, indirect, incidental, or consequential damages that may result from your participation or use of the app.
 - You release DesiHeart Inc., its directors, staff, and volunteers from any liability related to your participation, except in cases of proven gross negligence or willful misconduct.
